1. Undersigned, as Adoptive I declare that I adopt above described animal for myself and for my direct family. I also declare that I will not turn or give away or any other way the animal to a third person.
2. I declare that I will take care of the animal humanely and responsibly, I will ensure a clean and proper home, sufficient food and water and also the appropriate veterinary treatment. It is responsibility of the Adoptive parent to ensure the yearly due vaccination (rabies vaccines, vaccines against infectious disease, etc.) – which has to be documented in the vaccination book in a verifiable manner -, furthermore I will also ensure the anthelmintic agent as required.
3. I declare that I will keep the animal on my own property, I will not let him / her escape and to stray. I will not keep him / her on chain or lock him in kennel unduly and for longer time.
4. Additionally I declare that I will not abuse the dog physically, I will succeed the discipline and civilized behavior of the dog by nice words and motivation (toys, food).

*Remark of Kutyatár: It is suggested in the absence of experience with dogs to visit Best-Dog Dog School, which organization undertake free basic training of the dogs adopted from Kutyatár.*

5. I contract to teach my children for the knowledge regarding the dog is not a toy but instead a friend, beside that the dog is a serious task and responsibility.
6. I will provide a collar for him which indicate his / her name and address. I understand that as an owner starting from the day of the adoption I have an unlimited joint and severally liable for the dog.
7. As Adoptive I undertake to **spay the dog until her / his age of 8 months** at veterinary clinic of Baross Utcai Kisállat Rendelő (with Tímea Török veterinarian). If new home is my adopted dog is out of Kaposvár or its catchment area, his / her spaying still will be done with the new veterinarian and confirmation made by the veterinarian performed surgery will be sent to Kutyatár (to one of the following e-mail addresses: [epresedit@gmail.com](mailto:epresedit@gmail.com) or [sunshine19770919@gmail.com](mailto:sunshine19770919@gmail.com) or [mindenszofoglalt@gmail.com](mailto:mindenszofoglalt@gmail.com)).
8. In case of any further changes in housing conditions I would resign of the dog or I would be unable to take care of the dog, firstly I will inform Kutyatár about my intention.
9. I accept if Kutyatár proves that I don't take care of the dog according to above described, according to the requirements have described in the decree law on animal protection and keeping of pet animals, also according to the livestock regulations of local government and in existing legislation, Kutyatár could take the dog back from me without paying anything back.
10. I declare that information provided by me is true. As Adoptive parent I contribute for keeping my information by Kutyatár or its representative for private use and periodically inquire about the adopted animal. As Adoptive parent I also contribute the random inspections about the housing conditions of the dog made by Kutyatár.
11. I understood that in case of violation of Animal Protection Act and existing legislation Kutyatár or its representative will inform the authorities.

Parties indicate that cost of adoption – which cost is related with treatment of the animal (vaccines, microchip) – was paid by Adoptive parent against the required financial documents.

By signing this statement Adoptive parent notes that he / she is responsible for any damages caused by above described animal during the time spent together with the dog, therefore the Adoptive parent has to bear its financial burden.
